Aims:	To enable students to develop their understanding of how the Old Testament should be read in light of both its original and subsequent contexts.

	To provide students with an opportunity to develop their own practice of Old Testament interpretation.
Content:	A survey of different approaches to interpreting the Old Testament.
	Examples of how the Old Testament has been interpreted in the Christian tradition.
	Worked examples of how Old Testament texts can be related to a range of contexts.
	Developing students' own practice of using the Old Testament.
	The texts studied in this module must be at least largely different from those studied in other modules taken by the student on this programme.

Compare, contrast and evaluate alternative interpretative approaches to the Old Testament.

Analyse and evaluate how knowledge of context shapes the reading of Old Testament texts, articulating some of the questions to which this gives rise.

Apply different approaches to reading and interpreting Old Testament texts with a critical awareness of the questions raised by them.

Relate Old Testament texts to contemporary situations and practices of discipleship, ministry and mission, and explore questions to which this gives rise.

Reflect on their own practice of biblical interpretation.
