## Reflective Practice: Law and the Public Minister (TMM3671)

Aims: To support students in their ministerial development by developing

their engagement with well-informed and structured forms of theological reflection which underpin reflective practice in a

ministerial/professional/vocational context.

To equip students with an informed understanding of the relationship

between ecclesiastical law and theology.

To enable students to reflect critically on the role of law in the life and practice of the Church and in particular as part of the public role and

conduct of the minister.

To enable students to discuss intelligently some contemporary issues

arising from recent developments in civil law.

To develop an informed understanding of the concepts of law and rights from biblical and historical perspectives and within the law of

the Church.

Content: Note: The content of this module will vary according to denomination.

Biblical and theological perspectives on contemporary understandings

of law, rights and human dignity.

Critical exploration of the emergence of rights in western legal thought, including the rights of lay people in the Church and the duties and rights of ministers.

Human rights legislation and its impact on Church of England Canon Law, or its equivalent in other denominations.

The role of ecclesiastical law in guarding the Christian faith and defining the ecclesiology of a particular denomination.

Study of how Church of England Canon Law – or its equivalent in another denomination – governs the sacramental life of the church and the right ordering of worship, making appropriate use of case law and significant reports.

Examination of some contemporary issues arising from developments in civil law. In particular, the safeguarding of children and vulnerable adults will be studied in respect of: legal obligations, implementation of policies, establishing appropriate behaviours for clergy and laity, sacramental confession and ministry to survivors and abusers.

All of the above will be studied with reference to the students' professional/vocational practice by means of critical theological reflection.

Learning Outcomes: By the end of this module students will be able to:

Demonstrate a coherent and detailed understanding of the role of the law in the Church, its relationship with different theological disciplines and its impact on the rights and duties of laity and clergy, interacting with the methodologies and findings of current research, ecclesiastical law, reports and case law.

Articulate a critical and theologically informed understanding of some contemporary issues arising from civil law and the controversies surrounding them, explaining how they relate to aspects of faith, ministry and pastoral care.
