Aims:

To support students in their ministerial development by developing their engagement with well-informed and structured forms of theological reflection which underpin reflective practice in a ministerial/professional /vocational context.

To develop students' understanding of the distinctives and diversity of rural contexts and their implications for Christian mission, leadership and public ministry.

To enable students to interpret and analyse the narratives of rural communities and churches from a variety of methodological resources drawn from theology, sociology and anthropology.

To enable students to reflect critically on different models of structure and governance for multi-church groups and their effectiveness in supporting mission and ministry.

Content:

Examination of rural mission and ministry from biblical, historical sociological and theological perspectives.

Exploration of the distinctives for rural contexts with multiple communities of collaborative leadership, incarnational ministry, pastoral care, outreach, mission, evangelism, ecumenical partnership, worship and work with schools.

Critical reflection upon and application of current issues for rural communities to the ministry and mission of the church, including issue of political and social power and their impact on decision-making in rural contexts.

Practices and skills of collaborative leadership relating to team development and relationships, managing change, equipping and empowering others, problem solving, shared decision making and working with conflict.

Models for multi-church structures and their governance, including for Fresh Expressions of church.
